

Maricopa County Preliminary 2020 Ballot Analysis

01

We identified 609 voters that cast a ballot in the 2020 election that used voter IDs issued AFTER the 2020 election.

02

We identified 9 voters whose voter ID was canceled between 2017 and 2020 and were able to vote in the 2020 election (not provisional).

03

We identified 128 who have 2 voter IDs assigned to them. Both ballots were cast in the 2020 election, resulting in potentially 128 illegal votes.

****Big Problem****

Envelope is not supposed to be opened until **AFTER it is validated.**

Opening the ballot before signature is validated is a violation on A.R.S. 16-552

- F. If the vote is allowed, the board shall open the envelope containing the ballot in such a manner that the affidavit thereon is not destroyed, **take out the ballot without unfolding it or permitting it to be opened or examined and show by the records of the election that the elector has voted.**
- G. **If the vote is not allowed, the affidavit envelope containing the early ballot shall not be opened** and the board shall mark across the face of such envelope the grounds for rejection.

When the envelope is opened, the ballot IS NOT to be unfolded

Per A.R.S. 16-552

F. If the vote is allowed, the board shall open the envelope containing the ballot in such a manner that the affidavit thereon is not destroyed, **take out the ballot without unfolding it or permitting it to be opened or examined and show by the records of the election that the elector has voted.**

Doing so violates the secret ballot law
